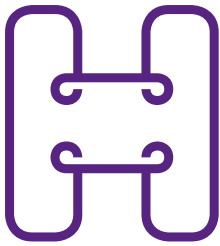

GIFT AID DECLARATION

Please treat all the qualifying gifts of money made today and in the future as Gift Aid donations

I confirm I have paid or will pay an amount of Income Tax and/or Capital Gains Tax for the current tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities that I donate to will reclaim on my gifts for the current tax year. I understand that other taxes such as VAT and Council Tax do not qualify. I understand the charity will reclaim 25p of tax on every £1 that I have given.

A DONATION IS WORTH MORE WITH GIFT AID

- Gift Aid is a simple way for our charity to increase the value of gifts of money we receive. When a UK taxpayer gives a gift of money to a charity, tax has already been paid. Therefore this qualifies for Gift Aid.
- Because we are exempt from tax, we can claim an amount equal to the tax paid by a donor on their donation as a repayment from HM Revenue & Customs (HMRC).
- Gift Aid allows us to claim back 25p for every £1 you give to us, boosting the value of your donation by a quarter. All we need from you is permission to reclaim the tax you have paid.
